2. Scope of work for Maintenance:-

For Maintenance works (Sr. # 1)

- (i) Repair/maintenance of floors, plinths, roofs.
- (ii) Repair of damaged walls, drains, doors, windows etc.
- (iii) Replacement of sanitary fittings, water supply etc.

For road works (Sr. # 2)

- (i) Scarifying of old bitumen surface where required.
- (ii) Tack coat on bituminous surface.
- (iii) Supply and lying of any thickness asphalt wearing course with 80/100 Asphalt
- (iv) Road marking Paint 03mm. Using Berger Road Marking Paint. (Thermo Plastic)
- (v) Repair of PCC paths, footpaths, Berms, Drains etc.

For Streets works (Sr. # 3)

- (i) Excavation for demolition of existing damaged Paths.
- (ii) Preparing surface and laying of PCC any thickness using crushed stone as specified.

For Electrical works (Sr # 4-5)

- (i) Provision/installation of PVC duct 3/4".
- (ii) Replacement of existing electric wiring with fittings Replacement of PVC wire 1.5 mm², 2.5 mm² & 6 mm².
- (iii) Supply/fixing of MCB 6-63 Amps.
- (iv) S/Fixing of MCB T/Pole 32 Amp

- i. NTN # and evidence of as active tax payers on ATL of FBR for **Income tax & sale Tax.**
- j. Bankers certificate showing Credit worthiness & auditor report of last three years.
- k. Proof of enlistment with other departments.

The applications shall be scrutinized and the tender documents will be issued to the contractor who have sufficient experience in the relevant field and satisfied other special conditions required for job and area.
