You are requested to submit quotations for the item(s) noted in the Schedule to the Tender. Offer should be sent duly sealed in an envelope. Please note the following instructions for filling the tender: -

1. SUBMISSION OF TENDER

1.1) Tenders will be opened at 1200 Hours on **12-09-2019** and must reach Bid Center on or before 11.30 Hrs upto due date. The tender received late will not be entertained. You may witness the opening of the tender if you so desire. If a representative is deputed, he should bring a letter of authority from you.

1.2) Only one tender should be included in one envelope. The outside of the envelope should be inscribed with: -

1.3) If envelope does not indicate reference of T.E (opened date) or received late the same may be returned un-opened.

2.GENERAL INSTRUCTIONS REGARDING PREPARATION OF QUOTATIONS

2.1) The prices should be filled in column 5 and delivery date in column 6 of the schedule to this Tender Enquiry. The undertaking should be signed at the bottom of the Schedule, which shall form the Quotation. You may use a separate sheet if necessary. Moreover, Technical and Commercial evaluation of bids will be carried out strictly as per PPRA Rule and contract will be awarded to lowest evaluated bidder.

2.2) **As per PPRA Rule 36 (b), Single Stage Two Envelope method** is / will be utilized for open competitive bidding. Therefore, you are required to quote in two parts:-:-

Part I **“Technical Offer”**: It should exclusively give technical details and literatures/brochures of the offered store; validity date, delivery schedule, and signed undertaking given on the schedule to this Tender Enquiry. It must not indicate price, costs etc.

Part II **“Commercial Offer”**: It should indicate the price, GST, Taxes and duties etc, where applicable.

Each part should be placed in a separate sealed cover. The envelopes should be inscribed with **Part I “Technical Quotation without Price”** and **Part II “Commercial Quotation with Price”**.

2.3) The Quotation must remain valid for, at least 90 days from the date of opening of tenders.

2.4) The Quotation should hold good for any reduced or enhanced quantities without notice.

2.5) In the event of non-acceptance of offer, no intimation will be given to the Tenderers.

2.6) Conditional Offer or alternative offers are likely to be ignored.

2.7) Quotations should be based on: -

Free Delivery at POF’s stores at WAH CANTT

In this case Octroi duty will be payable by the supplier.

2.8) Taxes and Duties etc. where applicable, must be shown separately, quoting reference to Registration No. in cases of Sales Tax and relevant authority in the case of others. Offers without clarifications and inclusive of Taxes and Duties may be ignored.

2.9) Taxes and duties levied on or after Tender opening date or on or after the date offer was signed and dispatched will be allowed to include in the offered rates provided that clause 2.8 has been confirmed properly.

2.10) “Suppliers will furnish a certificate, issued by Excise & Taxation deptt: that he has cleared all Professional Tax payable by him” offers received without this certificate will be rejected.

2.11) Supplier will render necessary information regarding hazardous effects on environment of the material/products supplied by them, and material Safety Data Sheet (MSDS), in their quotations and shipping/dispatch documents.

2.12) If the requisite information is not furnished on the T.E. forms or offer received is not conformity with the requirement / special condition of T.E. such offer shall be ignored.

2.13) Special Conditions must be carefully studied and conformed.

3. INSPECTION

3.1) Supplies shall be subject to the inspection and acceptance by the competent inspection authority nominated by the Purchaser, who will arrange it at his own cost. Inspection facilities such as tools, test equipment, instruments etc will, however, be provided by the suppliers in accordance with the relevant specifications.

3.2) Where considered necessary, by the Purchaser, the stores may be obtained on Warranty/Guarantee subject to inspection on receipt. Rejected stores will be removed and replaced with the acceptable stores by the Supplier at his own expense, with in a specified time.

4. **TENDER FEE**

The tender must be accompanied by a non-refundable fee by means of a crossed postal order / pay order of **Rs. 500** in favour of **Director Admin POFs Wah Cantt.** (attached with Technical offer)

TENDER SAMPLE

4.1) Where required, offer must accompany tender sample, strictly according to the description and specification given in Tender Enquiry. Offer not accompanied by tender sample will NOT be entertained excepting the established and reputable firms who have either previously satisfactorily supplied the same or similar stores or have submitted an acceptable sample thereof against previous T.E.

5. **BID MONEY**

5.1) Bid Money at the rate of 2% (for registered firms) and 5% (for unregistered firms) of the quoted value, should accompany the tender in the shape of CDR / Pay Order / Banker's Cheque , from a scheduled Bank drawn in favour of:-

DY.DIRECTOR SCM – II POF WAH CANTT.

Tenders received without Bid Money will be rejected. (attached with Technical offer)

5.2) Bid Money of the unsuccessful tenderers will be returned as soon as the scrutiny of the tenders is completed. Bid Money of the successful tenderers will be retained until the contract is finalized. Bid Money will be forfeited in case the quotation is withdrawn before the expiry of its validity date.

5.3) State owned organizations are not required to provide Bid Money.

6. **ACCEPTANCE OF OFFERS**

6.1) POFs may reject all bids or proposals at any time prior to the acceptance of a bid or proposal, but is not required to justify grounds for its rejection. POFs shall incur no liability towards supply or contractors who have submitted bids or proposals.

6.2) **Performance Bond:**

(a) The successful bidders shall provide performance bond at the rate, prescribed by POFs Boards according to the value of contract which shall not exceeding 10% of contract value, in the form of Deposit At Call Receipt from a scheduled Bank, or, an un-conditional Bank Guarantee valid for the 12 month after receipt of store in POFs on a prescribed format. The performance bond will be in favour of C.M.A (POFs) Wah Cantt and will be returned on satisfactory completion of contract.

(b) If the Supplier fails to furnish the Performance Bond within the specified time, such failure will constitute a breach of the contract and the Purchaser shall be entitled to make other arrangements for Purchase of the stores at the risk and expense of the supplier.

6.3 **PERFORMANCE BOND** from State owned organizations may be waived off at the discretion of the Purchaser.

6.4 **FAILURE TO SUPPLY THE STORES**

All deliveries must be completed by the specified date. If the failure to deliver the stores within the scheduled time should have arisen from "Force Majeure", which the purchaser may admit as reasonable ground for further time, he will allow such additional time as he may consider to have been required by the circumstances of the case. Otherwise, he will be entitled, at his discretion, to cancel the contract; and/or Claim liquidated damages up to 2% but not less than 1% of the contract price of the items and their quantities for each and every month or part of a month, beyond the specified delivery date, during which these may not be delivered, subject to a maximum of 10% of the total contract value of the particular stores which remained unsupplied either in part or in full; or, to purchase, from elsewhere, the unsupplied stores at the risk and cost of the supplier.

6.5 **PAYMENT**

Payment will be made by the C.M.A. - (POFs) through crossed cheques on receipt/acceptance of stores on our prescribed bill form supported by receipt voucher on part/full supply basis.

6.5(a) Payment of duties / Taxes including professional tax (where applicable) must be supported by proof of having paid these to concerned GOVT.Taxation Deptt.

7. **SECURITY OF INFORMATION**

The tenderer and his employees must not communicate any information relating to the sale/purchase of stores under this enquiry to any person other than manufacturer or to any press or agent not authorized in writing by POFs to receive it.

Please return the Schedule to the Tender duly signed by the specified date, along with the specifications, drawings etc. if any, enclosed herewith – even if you are unable to quote.

WARNING In case the firm abstain from making offers or fail to return / acknowledge the tender form by the specified date on three consecutive occasions, no further tender enquiry may be issued to them and their names would liable to be removed from the approved list.

(ix)	UNDERTAKING ON T.E. SCHEDULE SHOULD BE RETURNED WITH QUOTATION, DULY SIGNED & STAMPED
(x)	In case of registration with POFs, Registration Certificate may be attached with the quotation
(xi)	In case of failure to supply the store within Delivery Period, LD Charges will be imposed as per procedure.
(xii)	All the interested firms are required to submit the documentary evidence of their professional, technical, financial, legal and managerial competency for bid evaluation.
(xiii)	Advance Sample is required for test & trial, which may be provided within 10 days after opening of Technical Quotation.
(xiv)	Quotation must be valid for 90 days, which will be effective from the date of acceptance of samples / technical offers from our side.
(xv)	As per PPRA Rule (Two Envelop) Kindly send “TECHNICAL QUOTATION WITHOUT PRICE” and “COMMERCIAL QUOTATION WITH PRICE” shall be written in Block Capital Letters on the respective Sealed envelope which will be placed in a large envelope bearing complete detail of the Tender Inquiry. Bid Money & Tender fee will be attached with Technical quotation.

(xvi)	Firms not registered with POF are required to provide Annexure-A, along with the quotation, duly filled, signed and stamped.
(xvii)	The store will be obtained on firm's Warranty / Guarantee Certificate, supported with Test Certificates (where required).
(xviii)	The Input / representation of user group / factory will be part of procurement.
(xix)	Grand Total value of quoted items may be mentioned in the Commercial Quotation.

(4) **UNDERTAKING**
