5. Photocopy of veh Registration Book
6. Last year Token Number.
7. Photocopy concerned department card
8. Applicant will have to bear extra cost for exit pass of probable drivers
9. Authority letter by the concerned department Elaborating the reasons of entry *(For non resident only)
10. In case of three traffic violation the token will be cancelled
11. Issuing Authority reserves all the rights to cancel any token at any time without prior intimation
12. Token Fee to be deposit in account **No. 16046-6 of National Bank of Pakistan Aslam Market Branch Wah Cantt**

1. Original documents of all attached photocopies will be checked by the token office on submission of papers
