**No.232. ISSUANCE OF NOC FOR THE SALE/PURCHASE/TRANSFER OF
PROPERTIES IN RESTRICTED AREA OF WAH CANTT**

In supersession of this office note No. 4157/5/LR/OF-I/A-II, dated 8-11-77 and D.O. Pt-I No. 354 dated 11-6-89, Chairman POF Board has approved the following revised Terms and Conditions for issuance of NOC for the Sale/Purchase/Transfer of properties located in Lala Rukh, Officer's Colony, Gulistan Colony and other govt. leased housing schemes/colonies at Wah Cantt.

i. Scope

NOC for Sale/Purchase/Transfer of properties in the restricted area of Wah Cantt. pertaining to Officers Colony, Lala Rukh Colony, Gulistan Colony and other residential schemes of Wah Cantt. involving Govt. land, will be issued subject to security clearance where applicable. Besides, clearance certificate from POF employees Cooperative House Building Society (for Lala Rukh properties), Manager Gulistan Colony (for Gulistan Colony properties) and Anjuman-e-Tajran (for businessmen) will also be the pre-requisites. The NOCs will be issued by Deputy Director Admin in cases where serving and retired employees of POFs are involved. NOCs for all other categories and cases will be issued by Director Administration.

ii. Sale of Properties: Employees of POF and Allied Department.

NOC for sale of property to the serving and retired employees of POFs will be issued without security clearance. However, in case of dismissed/discharged employees of POFs and working employees of Allied Deptts., the requirement of security clearance by FIU is essential.

iii. Sale of Properties: Relatives of Employees of POFs.

Following relations of serving and retired employees of POFs will be eligible to purchase/transfer of property in Wah Cantt:

- a) Wife /Husband (without security clearance).
- b) Father/Mother/Brother/Sister/Son/Daughter (subject to security Clearance by FIU).
- c) Real Nephew/Niece (subject to security clearance by FIU).

iv) Sale of Properties : Outsiders.

All those who do not fall in the categories mentioned under (ii) and (iii) above will be considered as outsiders. The following outsiders will be eligible to sell/purchase/transfer of property subject to security clearance by FIU:-


- a) Bonafide businessmen having more than 10 years business period in the Wah Cantt or resident of Wah Cantt. having stay period more than 10 years (to be verified by Cantt. Executive Officer).
- b) Executives and officials of POF subsidiaries like Wah Nobel, Wah Industries Limited etc.
- c) Any individual who had purchased property on the basis of NOC issued by POFs, prior to the promulgation of present policy will be eligible to transfer the said property to one's husband/wife/father/mother/brother/sister or legitimate heirs.

2 Henceforth NOC for the purpose mentioned in para 1 shall be issued strictly in accordance with the above mentioned policy/guidelines.
