2. The contractors are required to submit their applications to GM Civil POF Sanjwal Cantt upto **30-11-2021 (Tuesday)** for issuance of tender documents. Contractors who are Active Tax payers list (ATL) of FBR for income Tax & Sales Tax and duly enlisted with Director Civil Works are eligible to submit their application.
3. For Pre-qualification, parties having experience, capability and resources may apply along with the following information and documents:-
 - a. Name of the firm along with Postal Address, Phone & Fax#.
 - b. Status of firm (partnership, deed, article of association or registration of firms certificate etc).
 - c. Copy of incorporation certificate & organizational structure.
 - d. PEC Registration in Cat. C-6 (min) with specialization code CE-01, CE-09, CE-10 & validity.
 - e. Similar nature of works upto Rs. 10 Million completed during last five years.
 - f. Similar nature of work in hand along with names and addressed of clients.
 - g. Pre-Qualified for similar nature of works with Govt., Semi Govt. / Private Firm.
 - h. List of key personal & detail of Technical Staff.
 - i. List of Machinery & Equipment owed.
 - j. NTN Number and certificate of professional Tax 2021-22
 - k. Bankers certificate showing credit worthiness & Auditor's Report of last three years.
 - l. Affidavit for nor blacklisted / involved in arbitration / litigation with any client during last 5 year.
 - m. Proof of enlistment with other departments.
4. Those who fail to provide above mentioned information / documents (at Sr. No. 3) shall be disqualified.
5. Contractors already working with POFs need only furnish particulars of works in hand outside POFs with the addresses of clients.
6. The application shall be scrutinized and the tender documents will be issued to the contractor who have sufficient experience in the relevant field and satisfied other special conditions required for job and area.
7. Tender will be issued to the scrutinized contractors upto **08-12-2021 (Wednesday)** and Tender documents are available in the office of AM Civil Maintenance POF Sanjwal Factory.
8. Tenders will be received back in the Bid Centre (Library) Welfare Club POF Sanjwal at 1030 Hrs on **15-12-2021 (Wednesday)** and opened at 1100 hrs on the same date. In case of Public Holiday, tender will be received on next working day upto 1000 Hrs and will be opened at 1030 Hrs on the same day.
