The tender received late will not be entertained. You may witness the opening of the tender if you so desire. If a representative is deputed, he should bring a letter of authority from you.

- 1.3 The bids received in factories will not be entertained.
- 1.4 If envelope does not indicate reference of T.E or received late the same may be returned un-opened.

2. GENERAL INSTRUCTIONS REGARDING PREPARATION OF QUOTATIONS

2.1 Case will be processed exactly as per **PPRA Rules 36(d)** in favor of most advantageous bid and **two stage two envelope bidding procedure** will be utilized for open competitive bidding. The prices should be filled in column 4 and delivery date in column 5 of the schedule to this Tender Enquiry. The undertaking should be signed at the bottom of the Schedule which shall form the Quotation. You may use a separate sheet if necessary

2.2 For Plant and Machinery, you are required to quote in two parts:-

It must not indicate price, costs etc. Only confirmation regarding submission of Bid Money may be notified with technical proposal.

Part II "COMMERCIAL OFFER" It should indicate the commercial terms e.g. price, terms of payment, mode of payment, mode of supply.

The commercial offer shall include separate price of;

- 2.3 The quotation must remain valid for, at least <u>120 days</u> from the date of opening of tenders.
- 2.4 The quotation should hold good for any reduced or enhanced quantities without notice.
- 2.5 In the event of non-acceptance of offer, intimation may be given to the Tenderers on their request.
- 2.6 Conditional offers or alternative offers are likely to be ignored.
- 2.7 Quotations should be based on **F.O.R** or **F.O.B**:
 - a) In case of F.O.R Basis Supply:
 - i. F.O.R. station of Dispatch basis, i.e. delivered free on rail, inclusive of packing and forwarding charges. The stores will be booked under Military Credit Note, to be provided by the purchaser. and/or Free delivery at POF's stores at <u>Gate # 6, JBH COMPLEX, POF WAH CANTT</u>.

In this case Octori duty will be payable by the supplier.

- ii. Taxes and Duties etc. where applicable, must be shown separately, quoting reference to Registration No. in cases of Sales Tax and relevant authority in the case of others. Offer without these clarifications and inclusive of Taxes and Duties may be ignored.
- iii. Taxes and duties levied on or after Tender opening date or on or after the date offer was signed and dispatched will be allowed to include in the offered rates.
- iv. Suppliers will furnish a certificate, issued by Excise & Taxation Deptt, that he has cleared all Professional Tax payable by him" Offers received without this certificate will be rejected.
- v. Suppliers will render necessary information regarding hazardous effects on environment, of the materials/products supplied by them, in their quotations and shipping/dispatch documents.

- vi. If the requisite information is not furnished on the T.E forms or offer received is not conformity with the requirement of the T.E such offer shall be ignored.
- vii. Payment of duties/Taxes including professional tax (where applicable) must be supported by proof of having paid these to concern Govt. Taxation Deptt:
- viii. Date and Stamp of the Postal Order must be visible.
- ix. The payment to the registered supplier will be linked with the active taxpayer status of the supplier as per FBR database. If any registered supplier is not in ATL his payment would be stopped till he files his mandatory returns and appears on ATL of FBR.
- x. Status of your firm with POF (Registered/Un-Registered) should be mentioned in your offer.
- xi. Registered firms are required to provide copy of valid registration letter with POF.
- xii. a. Only registered suppliers (with Sales Tax & Income Tax deptt) who are on Active Taxpayers List (ATL) of FBR are eligible to supply goods/services to Govt. Depts.

xiii. TENDER FEE

- i. The consignment will be shipped through Pakistan National Shipping Corporation (PNSC). In case there is no PNSC service in the country of shipping, please quote on C & F basis. The freight should be indicated separately. Insurance premium should not be included in the quoted price. However, where insurance is considered necessary, advice to that effect should be given in the quotation.
- ii. Submission of the offer through an agent in Pakistan should be avoided. In case it is considered inevitable, the agent's quotation must invariably be accompanied by the original proforma invoice from the principals/manufacturers.
- iii. Country of origin and port of shipment to be stated.

3. **ACCEPTANCE OF OFFERS**

The purchaser may reject all bids or proposals at any time prior to the acceptance of a bid or proposals, but is not required to justify grounds for its rejection. The purchaser shall incur no liability towards suppliers or contractors who have submitted bids or proposals.

4. **FAILURE TO SUPPLY STORES**

The specified delivery period (time and date of delivery / dispatch of stores) is the essence of the contract. All deliveries must be completed by the specified date(s). In failure to deliver stores within the scheduled time shall have arisen from "Force Majeure" which the Purchaser may admit as reasonable ground for further time, he will allow such additional time (without imposing liquidated demurrage) as he may consider to have been required by the circumstances of the case, of which he will be the sole judge and his decision will be final, otherwise he will be entitled at his option:

- a. "In case of unsupplied portion of the contract and unsatisfactory performance, the contract shall be rescinded by forfeiture of security and guarantee by the authority which approved award of the contract".
- b. "To recover liquidated damages when the government competent purchase officers on behalf of the government is satisfied that the failure to supply the stores within the scheduled delivery period has been for reason within the control of the suppliers and or if the government has suffered loss for reasons of belated delivery these liquidated damages if imposed will be recovered up to the rate of 02% but not less than 01% of the value of unsupplied quantity of the items per month or a part of a month for the period exceeding the original delivery period subject to the provision that the total liquidated damages thus leviable will be not exceed 10% of the total contract value of the particular stores which remained unsupplied either in part or in full."

OR

c. To withhold any payment due to the supplier until the whole of the stores have been supplied and/ or to direct deduction or recover, where considered necessary.

OR

d. To repurchase from elsewhere, at the risk and expense of the supplier, other articles of the same or similar description as he thinks fit to make good this default to the extent necessary, by canceling the contract, either wholly or for the unsupplied balance and with/ or without intimation to the supplier who shall be liable for any loss which the purchaser may sustain due to repurchase but shall not be entitled to any gain on repurchase.

5. **"FORCE MAJEURE"**

5.1 "Force Majeure" shall mean any event, Act / or other circumstances, not being an event, act or circumstances, under the control of the purchaser or of the supplier. The Supplier shall notify the Purchaser in writing of any such event within 15 days by Fax / Telex / Telegram of its commencement, which is relied upon by the supplier for its failure to comply with its obligation. The Purchaser shall have the right to conduct investigations to satisfy itself about the genuineness of the "Force Majeure" event. Non-availability of raw materials for the manufacture of stores, or of export permit for the export of the contracted stores from the country of its origin, shall not constitute "Force Majeure".

5.2 **FRUSTRATION**

If by reason of "Force Majeure" any consignment shall not be delivered by the due date, then the delivery period may be extended appropriately for the purpose provided the said consignment shall be ready within four calendar months of the stipulated delivery date. If the said consignment shall not be ready after the lapse of four calendar months as aforementioned, then the Purchaser shall have the right to cancel the contract informing the Supplier of the cancellation in writing. This, however, will not apply to consignments already accepted and delivered according to the terms of this contract. The Supplier will not be entitled to any compensation whatsoever as a result of this cancellation.

6. **SECURITY OF INFORMATION**

The tenderer and his employees must not communicate any information relating to the sale/purchase of stores under this enquiry to any person other than the manufacturer or to any press or agent not authorized in writing by POFs to receive it. Please return the Schedule to the Tender duly signed by the specified date, alongwith the specifications drawings etc. if any, enclosed herewith - even if you are unable to quote.

WARNING

In case the firm abstain from making offers or fail to return/acknowledge the tender form by the specified date on three consecutive occasions, no further tender enquiry may be issued to them and their names would liable to be removed from the approved list.

3. MAIN FEATURES OF EQUIPMENT

3.1 **General Requirement**

JBH Complex intends to purchase Propellant Sifting Machines for Triple Base Propellants (rosette shape, multi perforated grains) along:

- i. Feed Elevator
- ii. Charging Hopper
- iii. Sifting Plates
- iv. Driving Electric Motors
- v. Dust Collection System

3.2. Capacity of Machine

4. <u>DESCRIPTION OF THE MACHINE</u>

- 4.1. Material of construction used for the Sifting Machines along with related accessories shall be durable and compatible for sifting of propellants as per safe process requirement with international safety standard.
- 4.2. Contacting moving parts should be in combination of ferrous and non-ferrous material
- 4.3. Each sifting machine shall be properly earthed to dissipate static charge being generated during propellants sifting.
- 4.4. Speed of machine shall be easily adjustable through variable gearbox / VFD
- 4.5. Angle of machine shall be easily adjustable by hydraulic / manual mechanism.
- 4.6. Sieving plates must be easily replaceable.
- 4.7. Each sifting machine shall be equipped with plates cleaning system to remove chocking of plates during propellants sifting process.
- 4.8. All the equipment shall be capable to function in the environment with relative humidity more than 50%.

5. SCOPE OF SUPPLY

The supplier shall furnish all relevant technical data and drawings (04 complete sets in English language) in hard and soft form of sifting machines and related accessories including following;

- ii. P & I Drawings, Equipment Layout and Schematic Diagrams.
- iii. Process manuals for sequence wise start up, shut down & trouble shooting of the equipment and related accessories.
- iv. Complete layout showing electrical & safety installations.
- v. Maintenance and services manuals covering trouble shooting and schedule maintenance.
- vi. Complete safety manuals regarding operation & maintenance.
- vii. Configuration, programming and calibration manuals.
- viii. All programs and configurations fed to any instrument, VFD / soft starter shall be supplied in soft and hard form on USB and DVD with no restrictions
- ix. All engineering details, data and tables involved in calibration and process calculations shall be provided.
- x. Trouble shooting manuals for all instruments, electrical and mechanical equipment.
- xi. Specifications of materials not included in the supplies but necessary for integration of the sifting machines and related accessories.
- **xii.** equipment to be installed in existing building (documents / drawings are attached)
- xiii. Civil construction drawings (workshop drawings) required for Foundation Plans with Load Values for the equipment of sifting machine will be required from supplier.

12. **BATTERY LIMIT**

Battery limit means one meter outside the wall of the building up to which the purchaser will provide the required utilities / services. The purchaser will ensure to terminate all pipes with flanges at Zero level of building.

13. **INSPECTION:**

- Pre-shipment inspection (PSI) will be carried out by 03 members of POF team for a period of 05 working days (excluding journey period)
- ii. All Expenditures of the PSI and training teams i.e boarding, lodging, & return air tickets for the visiting team will be borne by the Buyer.
- iii. Inspection facilities for sifting Machines and related accessories such as tools, test equipment, instrument etc will be provided by supplier in accordance with the relevant specifications.
- iv. The supplier will arrange Pre-Shipment Inspection at their site. The Pre-Shipment Inspection will take place in following manner;
 - a. The team will inspect the machines in respect of material of construction, electrical & instrumentation specifications, spares quality and quantity.

- b. Verification that the equipment conforms to the ordered specifications. In this regard, the team will check the test certificates of the relevant items.
- c. Operation of the sifting Machines with the relevant media.
- v. During this period, the seller will also train buyer team regarding operation and maintenance of the sifting machines and related accessories.

14. TRAINING (On Site)

During the stay of supplier engineers/technicians at POF site, they will also train the purchaser concerned production, maintenance & instrument department personnel.

Number of trainees = 10

Duration of training = 01 week

15. <u>ERECTION AND COMMISSIONING</u>

- i. The purchaser under the working supervision of the supplier's engineers / technicians shall install the Vibratory Propellant Sifting Machines and related accessories.
- ii. The Sifting Machines along with related accessories will be commissioned by supplier's engineers. Purchaser shall provide the required number of operators / technicians for the commissioning.
- iii. The supplier has to indicate the total man-weeks of his engineers / technicians required for the erection, commissioning and trial run. Terms and conditions are to be stated clearly. All expenses including boarding, lodging, traveling and daily allowance of the supplier's engineers / technicians shall be borne by the supplier. However, local transport will be arranged by the purchaser.
- iv. The supplier shall provide the time schedule for successful completion of the project.
- v. The supplier shall replenish the quantity of spares used during installation, commissioning and trial run.

16. FINAL ACCEPTANCE TEST (FAT)

- i. The supplier shall provide guarantee for meeting quantity and quality of the finished product as per clause 3.2 (i & ii) [400 Kg / Hour]
- ii. Purchaser will provide the required number of operators / technicians and raw materials required for final acceptance test.
- iii. Trial run of the sifting machines will be considered successful if it produces 03 x MT as per requisite quality and quantity.

17. TERMS OF PAYMENT

Payment will be made as per following;

- b) **Balance 30% payment** will be released against the Final Acceptance Certificate, duly signed by the BUYER after the successful installation, commissioning & trial run of the store.

All Bank charges incurred in Pakistan in connection with the establishment of L.C. will be borne by the Purchaser, whereas all Bank charges incurred in connection with drawing of payment including charges for confirmation of L.C. by the advising Bank/Foreign Bank will be borne by the Supplier

18. ORIGIN

The machine will be accepted from USA / UK / EU / Japan / South Korea OR any country having manufacturing facility under license of OEM from above origins.

19. WARRANTY GUARANTEE

- i. The Sifting Machines and related accessories shall be accepted on Supplier's Warranty / Guarantee with regard to quality and quantity subject to these being technically checked / tested where necessary and accounted for on arrival at Consignee's ware-house in presence of supplier's rep (if desired by supplier) at their cost. The supplier shall render Warranty / Guarantee certificate in duplicate to the Purchaser on the enclosed Performa Annexure-'B' as soon as stores have been dispatched / delivered. This Warranty / Guarantee shall be binding on the Supplier for a period of 12 months reckoning from the date of successful final acceptance test of the Sifting Machines and related accessories.
- ii. In case the stores on checking / test after receipt at the BUYER's factory are found not conforming strictly to the relevant specification and other particulars, or found broken during transit, the SELLER shall immediately replace the rejected / broken store by acceptable stores free of cost and without any obligation to the BUYER. Rejected / broken stores shall be disposed by the SELLER under his own arrangements. The SELLER will warrant the good quality of all equipment supplied against all defects or failures due to faulty design, material or workmanship.

20. PERFORMANCE BOND

- The SELLER will provide a Bank Guarantee to the tune of 10% of FOB value of the contract for satisfactory execution of the order. It shall be covered by any Scheduled Bank in Pakistan.
