NOTICE OF TENDER

1. The office of Director Civil Works POF Wah Cantt invites sealed tenders for the following work in the light of PPRA Rule 13(l) of 2004.

CONSTRUCTION OF POF PROOFING RANGE COMPLEX (PPRC) AT BURHAN (PHASE-I)

2. The contractors are required to submit their applications to Director Civil Works, Quaid Avenue, POF Wah Cantt upto **08-12-2021** for issuance of tender documents alongwith their complete credentials as shown at (Serial 5). Contractors who are on Active Taxpayers List (ATL) of FBR for Income Tax & Sales Tax are eligible to submit their applications.
3. This project involves the following scope of works: -
 - a. 6 x Firing pts (2 x Trench and 4 x Lying).
 - b. Butt End (75 m wide)
 - c. 48 x Tgts.
 - d. 1 x Adm Block comprising 8 x Rooms along with 8 x Wash Rooms.

The applications shall be scrutinized and the tender documents will only be issued to the contractors who have sufficient experience in the relevant field and satisfied other special conditions required for the job and area. Tenders will be received by the Director Civil Works POFs Wah Cantt upto 1000 hrs on **18-12-2021** and opened at 1030 hrs on the same date. In case of Public Holiday, tenders will be received on next working day upto 1000 hrs and will be opened at 1030 hrs on the same day.
5. Contractors having experience, capability and resources may submit the following information/documents alongwith their applications: -
 - a. P.E.C Registration in C-3 or above for year 2022.
 - b. Similar nature of works completed during last three years with POFs or other Organizations / Departments.
 - c. Similar nature of works in hand alongwith names and addresses of clients.
 - d. Firms which are either registered with POFs (DCW) or firms holding valid registration with DW & CE/ACE/CMES/GE. (Attached Photocopy of Registration) or willing to get themselves registered with POFs are eligible to apply.
 - e. NTN No. and STRN No. and evidence of as active tax payers on Active Taxpayers List (ATL) of FBR for Income Tax & Sales Tax.

6. Those who fail to provide above mentioned Information / documents shall be disqualified.

7. The Authority reserves the right to reject any or all the pre-qualification applications under provision of PPRA Rules.
