
1. The office of Director Civil Works POF Wah Cantt invites sealed tenders for the following work in the light of PPRA Rule 13(I) of 2004.

2. The contractors are required to submit their applications (separately for each work) to Director Civil Works, Quaid Avenue, POF Wah Cantt upto **23-10-2021** for issuance of tender documents alongwith their complete credentials as shown at (Serial 4). Contractors who are on Active Taxpayers List (ATL) of FBR for Income Tax & Sales Tax and duly enlisted with Director Civil Works POF Wah Cantt are eligible to submit their applications.
3. The applications shall be scrutinized and the tender documents will only be issued to the contractors who have sufficient experience in the relevant field and satisfied other special conditions required for the job and area. Tenders will only be issued to the scrutinized contractor's upto 29-10-2021. Tenders will be received by the Director Civil Works POFs Wah Cantt upto 1000 hrs on **13-11-2021** and opened at 1030 hrs on the

same date. In case of Public Holiday, tenders will be received on next working day upto 1000 hrs and will be opened at 1030 hrs on the same day.

4. Contractors having experience, capability and resources may submit the following information/documents alongwith their applications: -
 - a. P.E.C Registration in C-6 or above for works at Sr. # i to vii and C-5 or above for works at Sr. # viii to x in para-1 for year 2022, otherwise PEC for year 2021 alongwith the evidence of the submission of renewal fee for year 2022 is acceptable.
 - b. Similar nature of works completed during last three years with POFs or other Organizations / Departments.
 - c. Similar nature of works in hand alongwith names and addresses of clients.
 - d. Proof of enlistment with Director Civil Works POF Wah Cantt.
 - e. NTN No. and STRN No. and evidence of as active tax payers on Active Taxpayers List (ATL) of FBR for Income Tax & Sales Tax.
5. Those who fail to provide above mentioned Information / documents shall be disqualified.
6. Contractors already registered/working with POFs also fulfill the requirement mentioned in above para-4.
7. The Authority reserves the right to reject any or all the pre-qualification applications under provision of PPRA Rules.
